### Kaupapa rōpū | Group purpose

The Financial Stability Group leads RBNZ's work on the stability of the financial system, including our assessment risks, vulnerabilities and opportunities in relation to financial stability, use of macro-prudential tools and ensuring that financial institutions are licensed, effectively regulated and supervised, and where applicable, enforcement and resolution action is taken.

### Kaupapa mahi | Role purpose

The Senior Analyst is a pivotal role responsible for conducting in-depth analysis and/or research across a range of areas to address complex questions and challenges. facing New Zealand and global economies. Leveraging strong technical and communication skills, this role contributes to shaping Reserve Bank policies, supporting decision-making, and advancing our understanding of central banking.

The Senior Analyst collaborates within their immediate team and across their Directorate and Group offering mentorship and leadership to junior staff, and actively engaging in project groups and initiatives across the Reserve Bank.

- Preparing high quality written research and analysis utilising delegations and decision-making frameworks and recommend preferred options for review and use by managers and senior leadership.
- Presenting and communicate all work in an accessible manner for a variety of internal and external stakeholders.

- Contributing to expert advice provided to senior decision makers and/or Reserve Bank committees.
- Ensuring compliance with internal procedures, reporting requirements and that the output of processes are achieving the desired results.
- Delivering outputs to Advisors and management within agreed timeframes.
- Assessing business process and workflows and act on opportunities for improvement.
- Developing and maintain effective working relationships with internal and external stakeholders.
- Support the implementation and execution of the Bank's strategy to modernise our supervisory approach.
- Leading analytical projects, providing guidance or coaching to junior colleagues.
- Operating with a one team mentality by collaborating with others to enable 'best for RBNZ' outcomes.
- Demonstrating our values and behaviours consistently to support our desired culture.
- Contributing as required to the delivery of Group and cross-functional strategies, activities, initiatives and programmes / projects.
- Supporting the integration of Te Tiriti, Te Ao Māori and diversity, equity and inclusion within our organisation.
- Taking proactive responsibility for your own health, safety, and wellbeing, and fostering a safe and healthy work environment by identifying, reporting, and managing risks and hazards.
- Developing and maintaining external relationships as required.
